On Thursday, June 3, the Tenant Action Council (TAC) picketed 1350 East Jefferson, an apartment building owned by the Goodman Bros. Realty Co.

They picketed to point out that Goodman was allowing slums to develop in our area while he appears to be a responsible landlord in their building.

In a leaflet which was given to the tenants in the building and passers-by, we pointed out that payment of rent entitles a tenant to at least adequate building protection, adequate fire protection and healthful living conditions. On the leaflet we asked them to help us in convincing Goodman Brosthat they have a responsibility to ALL their tenants.

At The St. Regis Hotel

On Thursday morning, May 27, at 6:45 a.m. six people were chained to the entranceways to the construction site at the St. Regis Hotel while others from TAC and CORE picketed and sang.

The "chain-in" was to show our determination to continue to protest the use of our rent money and our tax money for the building of a luxurious hotel by Goodman in the name of area redevelopment, while he allows our neighborhood to "slum".

NEW COUNCIL AT 1421 DELAWARE

We have had two meetings in the apartment building at 1421 Delaware owned by Sam Beznos. The first meeting was in the poorly furnished apartment of Cebie Johnson Jr. He told CORE and the Tenant Action Council that he is getting very little for his money. He has been tempted to move several times but he is going to stay in the building because there are people in the building that have worse living conditions than his. He said that he has seen most of the tenants apartments.

The Tenant Action Council members and CORE members have seen the living conditions of the tenants in the buildings. CORE and the tenant council agreed that the people are getting very little for their money.

We as members of the tenant council of 1421 Delaware would like our living conditions improved or we will take immediate action.

THE COURT

After six tenants filed suit in federal court against the Goodman Bros. Realty Co. for being evicted because they formed a group to better the living conditions in their building, the federal judge made them promise not to participate in any demonstrations against Goodman.

Because of this demand by the judge, the tenants decided to move their case into state level courts. They did this so they could participate with other tenants in demonstrations against Goodman, even though they decrease the possibility of a victory on the first round because at the state level the case is no longer a constitutional matter involving the right to free assembly.

As a result of the move to state court, the case was heard in circuit court on Wednesday, June 2, where the case was decided in favor of the defendant, Goodman Bros. We are appealing. We feel we lost this round because this court doesn't have the power to decide a case on the basis of its constitutionality. Based on constitutional rights, we feel we can't lose.

Tenants involved in the case were from 2210 Pingree, 1600 Seward, 1744 Seward, 2610 Webb and 1771 Seward.

GOODMAN CONTINUES TO FIGHT CORE & TAC

On Friday, June 4, the six chainins from the St. Regis were arraigned for the second time.

After trespassing charges against the six were dropped by the construction superintendent at the St. Regis, Goodman brought the same charges.

There must be money in it for him!!!

The Building Tenant Council

The Tenant Action Council (TAC) is the united tenant councils of our community. Its function is similar to that of the federal branch of our government. If we look at the tenant councils as the 50 states, each having its own problems and each located in a different building, TAC is the organization where all the building councils unite to form a true community approach to our neighborhood problems in the same manner that the fifty states unite to form a national government.

In the past, TAC's attacks on our opposition have been indirect, even though there are many direct actions and more effective actions on our drawing boards. We've been indirect because of a lack of numbers. For example, the most effective way to cause a landlord to change his ways is to cut off the money we pay him for the things we don't get. But without complete cooperation, a rent strike couldn't have its greatest effect.

TAC PLANS ANOTHER RALLY

The Tenant Action Council (TAC) is concluding plans for their second rally, continuing their effort to involve the entire 12th Street area in our fight to better our way of life. The rally is planned for Saturday, June 12 on Pingree between 14th and La Salle.

The first rally was May 15 on Woodrow Wilson between Seward and Delaware. The response from that area was so great that we are still making first contacts.

We hope that response from our second rally will be even better than from the first.
