To Members of Citizens Committee on Police-Community Relations



Gentlemen:

Your ad hoc Citizens Committee on Police-Community Relations has held several meetings for the purpose of discussing and agreeing upon a common approach in our future meetings with the Mayor or other city officials.

One result of these discussions has been the preparation of the enclosed copy of a letter which it is proposed will be sent to the Mayor over the signature of each organization represented on our Committee. Dear Mayor Cavanagh:

This letter is being sent to you at the expressed direction of our respective Boards of Directors and we are authorized to release it to the press after allowing a reasonable time for its receipt by your office.

Shortly after your 1961 victory over former Mayor Mariani and prior to your inauguration you held several conferences with the representatives of our community organizations for the purpose of exchanging views on civic problems of special concern to Detroit's Negro citizens.

At both of these conferences and in your campaign pledges you gave repeated assurances of your intention to accomplish two objectives in the Police Department: to accelerate the integration of the Police Force and to end the excesses of police lawlessness and special brutality toward Negroes which characterized the last year of the Mariani administration.

Integration of Police Department:

Your record on integrating the Police Force deserves our commendation. The progress has not been as rapid as we had hoped but we appreciate the fact that you and your Police Commissioners have had to overcome the obvious racial prejudice and antagonisms of several of the older leaders of the force. In recent months,

however, with the retirement and replacement of some of these roadblocks to integration, we see more and more evidence of your determination to keep this commitment. We commend especially the several appointments and changes requested some time ago and made by the Police Commissioner within the past few days.

Anti-Negro Conduct of Policemen:

The sincerity of your pledge to end the anti-Negro conduct of certain policemen was evidenced shortly after the above conferences by your appointment of former Supreme Court Justice Edwards as your new Police Commissioner. Commissioner Edwards made a determined effort to "humanize" and restore public confidence in the fairness of the Department, but what little success he experienced was due to his persistence and not to any cooperation received from the "Top Brass" of the Department.

For example: Records available to you and the Police

Commissioner show that between May of 1961 and February, 1964, more

than 1,000 citizens sustained physical injuries at the hands of Detroit

Policemen. Over 600 of these were Negro, notwithstanding Negroes

constitute less than one-half of the City's population. During the

year 1963 alone there were almost 500 cases of police-inflicted

injuries; and 300 of these were in the five predominantly Negro

precinct areas.

Also in 1963 there were approximately thirty-five formal complaints against police officers. Twenty-seven (27) of these complainants were Negro, ten were white and all of the officers complained against were white. The disposition of these complaints is most revealing. Ten of them were referred to the Police Trial Board and were decided in favor of the officer; the other twenty-five were decided for the complainant with the approval of the Police Commissioner and without Trial Board action.

The current wave of anti-Negro brutality dates from

Commissioner Edwards' resignation. We know that his successor, the

present Commissioner, Mr. Girardin, is a well-meaning, dedicated

public servant who would like to make - and is endeavoring to make
the Police Department the kind of civilian-controlled law enforcement

body mandated by our City's Charter. But the power clique in the

Department (aided and abetted by a County Prosecutor whose office has

become adept at white-washing policemen involved in the shooting of

unarmed Negroes) is blocking Mr. Girardin's good intentions just as they

check-mated the more vigorous program of Commissioner Edwards.

The Police Commissioner cannot make your pledge a reality, Mr. Mayor, unless he has your <u>publicly expressed</u> support and backing each step of the way. The corollary is also true: if your pledge is not fulfilled and notwithstanding such failure, the Commissioner is retained in office, then the obvious conclusion is that you do not want the pledge implemented.

Detroit's Negro Community - with generous support in the white community - is united in its demand that your campaign pledge to put an end to the anti-Negro conduct of our Police Department be implemented. How this is to be achieved is a matter we leave to you. We have some recommendations which we are prepared to discuss with you or your representative. Chief among these is a stepped-up program of integration; returning the Department to the civilian control mandated by the Charter; and assuring a fair degree of Negro participation in that control.

Meanwhile, we suggest that the Mayor's responsibility under the Charter cannot be avoided by reliance upon the legalistic conclusions of Mr. Gallagher, your Assistant Corporation Counsel.

Mr. Gallagher is not dependent upon - and hence, may not be responsive to the will of the people as expressed at the polls. It is easy for him to write off or to simply ignore the legitimate aspirations of a third of the City's population who happen to be Negro. We doubt if a Mayor of Detroit can be so naive.

Moreover, Mr. Gallagher's comments, as reported in the press, show a studied reluctance to examine the Charter affirmatively with a view to helping you find a method by which this explosive situation can be remedied. We think the approach of Corporation Counsel Reese, as reported in the press, is more in accord with the Charter.

It is apparent from the Charter and applicable Court

decisions that the Mayor is the final authority in the Police Department. Chapter III of the Charter provides that the Mayor shall be "the Chief Executive Office of the City and conservator of its peace," and Chapter XXI authorizes him to appoint a Police Commissioner "who shall have charge of the Police Department." The Michigan Supreme Court has held that this power to appoint includes the power to remove. Nagel v. Martin, 229 Mich. 282. Thus, the Commissioner exercises all of his powers and performs all of his duties subject to the approval of the Mayor.

Among other things the Police Commissioner is expressly authorized by the Charter to "exercise supervision over the Police Department and make all proper rules for the government and discipline thereof." He also is authorized to "create whatever offices and positions he may deem necessary."

It seems clear to us, therefore, that if the Mayor or the Commissioner wants to find a way in which the anti-Negro conduct of policemen can be ended once and for all time, the above Charter language is broad enough for the purpose.

Our organizations and the entire Detroit Negro Community are waiting, Mr. Mayor, for you to exercise your authority under the Charter and now to implement your campaign promise to end police brutality against our Negro citizens.
