What Is The Civil Rights Federation?

HE CIVIL RIGHTS FEDERATION was formed three years ago to give common voice to the spontaneous protest of church, liberal and labor organizations against the fascist and undemocratic Dunckel-Baldwin Bill proposed to the Michigan Legislature. This unity of protest raised a voice so loud that the Bill was defeated and the Federation became the champion of civil liberties. Since then it has continued the fight for liberal legislation;—exposed the Back Legion —exposed vigilanteism at the time of the sit-down strikes—helped stage the giant mass meeting at Cadillac Square to protest police violence against strikers—fought for the right of the people to use the public schools for civic purposes; continually protested against Nazi and fascist activities; provided educational facilities so that we might know wherein our freedom and democracy was threatened and ever opposed any violation of civil rights that was brought to its attention.
